Who needs this licence?

Medium sized digital music services that offer on demand streaming, permanent downloads and webcasting to a UK audience. We categorise services as medium if their annual gross revenue is between £12,500 and £200,000.

What this licence covers

LOML+ covers the communication to the public and associated mechanical rights (excluding synchronisation) of our members' repertoire through digital services.

What are the reporting requirements

You need to report the music used on your service at the end of each quarter. We use this information to distribute the licence fees you have paid to our members - songwriters, composers and music publishers.

LOML+ does not cover

- Sound recording rights – visit ppluk.com for more information
- Services operating outside the UK
- Synchronisation right
- Use of music in adverts, sponsorship or corporate videos
- Adaptations of works
